- The' empowering of the President or the Business Manager' is primarily for convenience, and it will give the District the ability to react quicker than monthly meetings allow.
- Passing of this resolution means that the Scope of Services from HDR for the Blower Replacement Project will be accepted. This revised scope of services is \$249,830 less than the original scope of services for the project.
- The project is intended to continue the effort to reduce nitrates. This effort has been in place since 2008 when Ecology proposed nitrate limits on our permit.
- The resolution was approved.
- 2. Stevens Pass Resort's Yodelin Lodge employee housing connection plan.
 - Christie Voos and Alecia McConnell discussed the resort's general plans for the reconnection of the Yodelin employee housing building.
 - They intend to use materials that are consistent with District regulations so that the connection is no longer considered "interim".
 - The general plan is to use 2" HDPE pipe that will have heat tape added at the bridge crossing. It will also be well insulated.
 - The planned time frame is after Labor day. The road in the area will likely be closed during this time and the lower road will need to be used as an alternate.
 - The plans will be finalized in the next few weeks and submitted to the District for approval.
